

# TASG Privacy Policy

## Introduction

Top Athlete Sports Group (“TASG,” “we,” or “us”) respects your privacy and is committed to protecting it through this policy. ## Children

We do not knowingly collect personal information from children below the age of consent in their jurisdiction. If we discover we have received such information, we will delete it promptly.

## Information We Collect

We may collect the following types of information:

- **Personal Identifiers:** name, email address, phone number, date of birth, nationality, social media handles.
- **Athletic Information:** sport, height, weight, statistics, highlight videos, club/team history, competition records, national team or tournament experience.
- **Academic Information:** GPA, transcripts, graduation year, standardized test scores (SAT, ACT, TOEFL, IELTS, Duolingo), intended field of study.
- **Contact Information:** correspondence you send us, inquiries, or registration forms completed through our Website.

- **Technical Information:** IP address, browser type, device type, and Website usage data (collected automatically through cookies or analytics tools).

We do not collect biometric, genetic, medical, or union-related information.

## How We Collect Information

- **Directly from you:** when you register, fill out forms, or contact us.
- **Automatically:** when you navigate our Website (cookies, analytics, and similar tools).
- **From third parties:** such as publicly available coach directories, recruiting databases, or partners who help us provide services.

## How We Use Your Information

We use the information we collect for purposes such as:

- To create and manage athlete recruiting profiles.
- To present your information to U.S. college coaches and institutions for recruiting opportunities.
- To provide you with academic placement support and related services.
- To manage NIL (Name, Image, and Likeness) representation where applicable.
- To communicate with you regarding opportunities, updates, and support.
- To improve our Website, services, and user experience.
- To comply with legal and regulatory requirements.

We do not sell personal information.

## Disclosure of Your Information

We may share your information in limited ways:

- **With coaches and schools:** for recruitment and scholarship placement purposes.
- **With service providers:** such as translators, payment processors, or academic evaluators who help us deliver services.
- **As required by law:** to comply with court orders, laws, or regulatory requests.
- **With your consent:** when you explicitly authorize sharing.

## Cookies and Tracking

We may use cookies and analytics tools (e.g., Google Analytics) to understand traffic and usage patterns. You may adjust your browser settings to refuse cookies, but some parts of the Website may not function properly.

## Data Security

We use reasonable physical, electronic, and administrative safeguards to protect your information. However, no method of transmission over the Internet is 100% secure, and we cannot guarantee absolute protection.
